## Report on Marshall Board

That the highway department is in good shape seems to be the consensus of the Town Board of Marshall. Meeting on Jan. 8 at the Dean Mansion, all board members were present, welfare officer Robert Dawes and Town Attorney Gordon Jeffery also attending. Also attending was a representative of Casteletti Pontiac which has just delivered a new pickup truck for under \$200 (with trade). \$585 has been spent on highway barn improvements, the mower has been repaired and readied for spring; and it was decided to buy new tires for the pay loader at state price, and an air compressor from Tom's Auto Supply for eleven or twelve hundred dollars. No bids are needed as the limit is now \$1500.

Appointments for the year were routine, with few changes. On the question of mileage which has stood at 8 cents for legitimate town business, a policy of asking that individual estimates at budget time include mileage, with an implied choice of "no raise or no gas" was set.

Justic Curtis Cook was authorized to attend the Association of Towns meeting in New York City Feb. 5, 6 and 7. Jeffery also is attending. Included in the policy for the year was the setting of the first Tuesday after the first Monday of the month for the regular meeting with the exception of November, when the meeting is held the Thurs. following Election Day. Added to this was an exception for Feb. 1974 when the board will meet Feb. 12, so that Cook may be present.

Cook moved that the Village of Waterville be commended for cleaning up the dump, long a local eyesore. It was decided to ascertain if lumber can be sold from the "Day Farm," Councilman Kurt Schachtler warning against stripping and the board concurring.

### FREE GLAUCOMA TESTS

Tests will be given to anyone who is 35 years old and over. Younger people with symptoms of Glaucoma will be also be given an appointment

## VILLAGE OF WATERVILLE Dog Ordinance

No dog shall be allowed to run free in the village of Waterville. Dogs shall be confined to the premises of the person who owns or harbors dogs in such a way that they cannot reach a public sidewalk or other property. Any dog not confined shall be on a leash.

A violation of this ordinance shall subject the person who owns or harbors such a dog to a fine of not more than \$25.00 nor less than \$5.00 for each offense.

In addition to the foregoing any dog running free in the Village may be taken and confined under the direction of the Village for a period of three days, after which it may be disposed of. During such three day period the person who owns or harbors such a dog may claim the dog upon payment to the Village of the sum of \$5.00 plus the expense of taking and confining the dog.

No dog shall cause a public nuisance by extended barking or howling. A violation of this section shall subject the person who owns or harbors such a dog to a fine of not more than \$25.00 nor less than \$5.00 for each offense.

- NOTE: Summons are now being issued to offenders.

## Postmasters urge use of box numbers

Postmasters Billings and Fallon today urged all rural and star route postal customers served by the Oriskany Falls and Waterville post offices to use box numbers as part of their return addresses to assure faster, more efficient mail deliveries from correspondents.

"Although box numbers are an integral part of most rural and star route addresses, it has recently become the practice of many postal customers to omit this element.

"This practice sometimes causes mail to be returned to the sender because of an insufficient address. It has also been cited by publishers and other large mailers as one of the major causes of duplicate mailings to rural customers.

These duplicate mailings hurt everyone. They cost the big mailers in dollars and cents, and because they flood the mail stream, everyone's mail is slowed.

Postmasters Billings and Fallon said the box number is as important to rural and star route addresses as the house number is to the city addresses.

Unless a rural or star route address contains both, the box number and the route number, it is an incomplete address and is subject to return to the sender.
