LAST WILL AND TESTAMENT

I, PETER J. IMHOFF, a resident of the Town of New Hartford, County of Oneida and State of New York, being of sound and disposing mind and memory, do hereby make, publish and declare this to be my Last Will and Testament in the manner following:

FIRST: I hereby revoke all Wills and Codicils by me at any time heretofore made.

SECOND: I hereby direct that all my just debts, funeral and testamentary expenses be paid as soon as conveniently may be after my decease.

THIRD: All the rest, residue and remainder of my estate, both real and personal, of whatsoever kind and nature and wheresoever the same may be situate, of which I shall die seized or possessed or to which I may in any wise be entitled at the time of my decease, I give, devise and bequeath unto ELOISE HAWKINS, to belong to her absolutely.

FOURTH: In the event that said Eloise Hawkins shall predecease me, then I hereby give, devise and bequeath all the rest, residue and remainder of my estate, both real and personal, of whatsoever kind and nature and wheresoever the same may be situate, of which I shall die seized or possessed or to which I may in any wise be entitled at the time of my decease unto my son, Joseph H. Imhoff.

FIFTH: I knowingly make no provision in this my Last Will and Testament for my children, Alexis L. Imhoff and Odellia P. Dote.

SIXTH: I hereby nominate and appoint Eloise Hawkins to be executrix of this my Last Will and Testament. In the event said Eloise Hawkins shall predecease me or shall fail to qualify or cease

to act as such Executrix then I nominate and appoint my brother, John Imhoff, to be executor of this my Last Will and Testament. I hereby authorize my said executrix or executor to sell or convey at public or private sale all of my property, both real and personal, on such terms, prices, consideration and conditions as she or he shall deem to be for the best interest of my estate.

SEVENTH: I direct that no bond be required of my executrix or executor for the performance of any of her or his duties as such executrix or executor.
